In accordance with the provisions contained in Section 3A of the Haryana Municipal Act, 1973 read with Rules 4 to 11 of the Haryana Municipal Election Rules, 1978 and the powers conferred under clause(1) of article 243ZA of the Constitution of India the, State Election Commissioner, Haryana hereby directs for the preparation of ward-wise and booth-wise photo based electoral rolls in respect of all wards of the Municipal Committee , Dharuhera (Rewari) with reference to 1<sup>st</sup>, January, 2014 as the qualifying date.

2 The draft electoral rolls of the Municipal Committee, Dharuhera shall be prepared with the help of National Informatics Center by converting the relevant parts of the Assembly Electoral rolls, finally published on 15.01.2014 into the wards of the Municipal Committee. The electoral rolls shall be prepared on the format attached at Annexure-“A” . and in accordance with the procedure and schedule given hereunder:-

i	<b>Start of preparation of draft electoral roll:</b> The ward-wise and booth-wise photo based draft electoral rolls of all wards of the Municipal Committee, Dharuhera shall be prepared as per delimitation published by the Government vide notification No.18/146/2013-3C-1 dated 13.12.2013, in the format Annexure 'A' on the basis of latest database and Assembly electoral rolls published on 15.01.2014 with reference to 1st January, 2014 as the qualifying date and deleting the names of persons, who had died and also of those who are found to be no longer ordinarily resident in the territorial limits of the Municipal Committee. v	Last date for filing appeals with the Deputy Commissioner against the orders of Revising Authority. (Rule-10(2))	03.03..2014 (Monday)
vi	Last date for disposal of appeals by the Deputy Commissioner.(Rule 10(3))	13.03.2014 (Thursday)
vii	Final publication of Electoral Rolls.(Rule-11)	15.03.2014 (Saturday)

3. It is further directed that database with photo images of the electors and four copies of Assembly Electoral Rolls finally published on 15.01.2014 with reference to 1<sup>st</sup> January, 2014

as qualifying date shall be obtained free of cost from the Election Tehsildar/Election Naib Tehsildar concerned.

4. It is further directed that while preparing the draft electoral rolls, it should be ensured that names of the persons, who had died and also of those who are found to be no longer ordinary residents within the limits of the Municipal Committee, but their names are still existing in the Assembly electoral rolls finally published on 15.01.2014 should not be included in the draft electoral rolls of the Municipal Committee.

5. It is further directed that:-

- (i) The Deputy Commissioner shall give wide publicity to the above programme. He shall issue press notes and also paid advertisements in two local newspapers. He shall also make publicity through local cable network.
- (ii) The Deputy Commissioner shall publish, on the date prescribed in sub-para(ii) of para 1 above, the draft voter list along with a notice including the dates by and the places where the claims and objections with reference to the draft rolls may be presented to the Revising Authority/Authorities.
- (iii) One copy of the draft electoral roll, published for inviting claims and objections, shall be kept for inspection of the public free of cost at the following places:-
  - a Office of Deputy Commissioner,
  - b Office of Secretary of the Municipal Committee,
  - c Office of Sub-Divisional Officer(Civil)'s concerned,
  - d Tehsil Office concerned,
  - e Office of Revising Authority/Authorities and
  - f Voter Information and Collection Centers
- (iv) After the draft publication of the ward-wise electoral rolls, the same should also be hosted on the website of the District Administration and State Election Commission for information of the public.
- (v) A copy of the draft and final rolls shall be duly signed by the officers/officials not below the gazetted officer and shall be kept in a sealed cover in the Treasury within 24 hours from the date of the publication of draft and final electoral rolls respectively.
- (vi) In order to facilitate the electors and the public to obtain information regarding electoral rolls and to file claims and objections, the Deputy Commissioner shall set-up suitable number of Voters Information and Collection Centers (VICC) within the territorial limits of the Municipal Committee. These centers shall be fully equipped with computers and broadband internet connection. The center will be set up with the help of the National Informatics Center..
- (vii) Any person who desires to file his claim/ objection through online can submit his application on Harsamadhan by date specified in this notification. Such persons would have to appear before the Revising Authority/ Authorities or at the VICC along with filled up the prescribed form.

- (viii) The VICC centers will make available the prescribed forms, on demand free of cost, for filing claims and objections and receive the same for the consideration of and decision by the concerned Revising Authority or the officers authorized for this purpose. The forms shall also be hosted on the website of the State Election Commission and the District Administration. The forms can be downloaded and used by any person for filing claim and objection.
- (ix) As and when any person files claim and objection, he shall be given a receipt in the prescribed format given in the form. An entry shall also be made in internet based monitoring system and registers.
- (x) The Deputy Commissioner shall appoint one Authorized Officer no below Group-B for maximum up to three wards and sufficient number of required supporting staff and other officials of Municipal Committee, to assist the Revising Authority/Authorities to discharge his/their duty.
- (xi) The Revising Authority/Authorities shall, after holding such enquiry into the claims or objections as he/they think(s) fit, record his/their decision in writing and shall make available forthwith a copy of such decision to the objector or claimant free of charge. The decision of the Revising Authorities shall also be hosted on the website for the information of the public. Number of claims/objections accepted and rejected shall also be hosted on the website of the District Administration in the internet based monitoring system. The software to be used for this purpose shall be provided by National Informatics Center, Haryana.
- (xii) The Revising Authority/Authorities after disposal of all the claims and objections in terms of under Sub-rule(1) of Rule 10 of the Haryana Municipal Election Rules, 1978 shall forward a list of such claims and objections along with his/their orders thereon to the Deputy Commissioner. Any person aggrieved of any such order of the Revising Authority/Authorities may, within prescribed period, file an appeal to the Deputy Commissioner. The Deputy Commissioner shall within the specified time decide the appeal. The decision of the Deputy Commissioner on appeal shall be final.
- (xiii) The Deputy Commissioner shall publish the ward-wise and booth-wise photo based final electoral rolls on 15.03.2014, which shall come into force immediately after the publication.
- (xiv) After completion of every stage of the preparation of electoral rolls process as stated above, the Deputy Commissioner shall send information of the statistical data in format Annexure "B " to the State Election Commission, Haryana.

6. It is further directed that copy of ward-wise and booth-wise photo based electoral rolls of the Municipal Committee, Dharuhera finally published on 15.03.2014 shall be submitted to the State Election Commission, Haryana on the same day. In addition, two copies of the electoral rolls along with a CD(compact disc) containing the database of the same in PDF

format shall be sent to all the political parties in the State of Haryana on the same day under intimation to the Commission.

7. It is further directed that the final electoral rolls of Municipal Committee, Dharuhera shall be hosted on the website of the District Administration on the day they are published.
