Subject:- Criminalisation of Politics – Participation of Criminals in the electoral process as candidates – disqualification on conviction for offences – effect of appeal and bail regarding.

Sir,

I am directed to invite your attention to the instructions issued by the State Election Commission, Haryana, vide its communication No.SEC/ME/1997/14090-140108, dated 29.9.1997 and No.SEC/ME/1998/ 2495-2514, dated 13.2.1998 on the subject noted above and to say that the proforma of the Annexures which were prescribed and annexed with Commission's letter dated 29.9.1997 mentioned as Annexure-II, (a letter from Returning Officer to the candidate for filing affidavit and furnishing information on the proforma under Section 8 of the Representation of the People Act, 1951 and sub-section (1) and sub-clause (ii) of clause (d), clause (e) and (m) of sub section (2) of Section 8 of the Haryana Municipal Corporation Act, 1994, read with sub-rule (1) of rule 23 of the Haryana Municipal Corporation Election Rules, 1994 and format of the Affidavit required to be filed by the candidate before the Returning Officer with the nomination papers.

2. The format of the letter (i.e. Annexure –II) by the Returning Officer to the candidate about supplying information relating to the disqualification under Section 8 of the Representation of the People Act, 1951 and sub-section (1) and sub-clause (ii) of clause (d), clause (e) and (m) of sub section (2) of Section 8 of the Haryana Municipal Corporation Act, 1994, read with sub-rule (1) of rule 23 of the Haryana Municipal Corporation Election Rules, 1994, and the format of the affidavit filed by the candidate before the Returning Officer alongwith proforma for furnishing information under Section 8 of the Representation of the People Act, 1951 and sub-section (1) and sub-clause (ii) of clause (d), clause (e) and (m) of sub section (2) of Section 8 of the Haryana Municipal Corporation Act, 1994, read with sub-rule (1) of rule 23 of the Haryana Municipal Corporation Election Rules, 1994, as prescribed in the above mentioned two letters of the Commission have now been revised.

3. I have also been directed to invite your attention to the order No.SEC/E-III/2003/8831, dated 06.10.2003 issued by the Commission, requiring a candidate to file an Affidavit for disclosure of information about the conviction and equittal/ discharge in criminal cases, and details of pending criminal cases in which charge has been framed or cognizance has been taken by the Court and details of the assets, liability and educational qualification of the candidate.

2. Under these revised instructions for the Municipal elections to be held hence after, while supplying the nomination papers, the Returning Officer shall inform the intending candidates in the manner prescribed in Annexure –I attached herewith that he should file an affidavit in Annexure-II enclosed alongwith the proforma for furnishing information under Section 8 of the Representation of the People Act, 1951 and sub-section (1) and sub-clause (ii) of clause (d), clause (e) and (m) of sub section (2) of Section 8 of the Haryana Municipal Corporation Act, 1994, read with sub-rule (1) of rule 23 of the Haryana Municipal Corporation Election Rules, 1994, and also another Affidavit in Annexure-III for furnishing information about the conviction and equittal/ discharge of criminal offences, pending criminal cases and details of assets, liability and educational qualifications as required under Commission's order No.SEC/E-III/2003/8831, dated 06.10.2003. The Returning Officer shall give copies of the Annexures II and III referred to above, to the intending candidates alongwith nomination form so that the candidate may file these affidavits alongwith the nomination form to be submitted to the Returning Officer.

3. On receipt of the nomination paper, if a candidate does not file any of the two affidavits i.e. affidavit in Annexure-II and affidavit in Annexure-III or both these affidavits, then the Returning Officer shall issue notice as in Annexure-IV to the person delivering the nomination papers that the candidate should file the affidavit immediately and positively before 10.00 A.M. of the date of scrutiny, failing which the nomination paper of the candidate shall be rejected.

4. On receipt of the nomination paper, the Returning Officer shall also write to the candidate as prescribed in Annexure-V informing him about the serial number in the nomination register at which his name has been entered, scroll number vide which security received and the date, time and place of the scrutiny of the nomination papers as prescribed in Annexur-V.
