NO. SEC/2ME/2012/184 :- Whereas the State Election Commission, Haryana vide its Notification No. SEC/2ME/2012/40 dated 13.01.2012 had prescribed the programme for the preparation of electoral rolls of all wards of the Municipal Committee Julana (Jind), Hathin (Palwal), Farukh Nagar (Gurgaon), Kanina, Ateli Mandi (Mahendergarh) and Loharu (Bhiwani) intensively on the basis of Assembly Electoral Rolls prepared with reference to 1st January, 2012 as qualifying date and finally published on 05.01.2012 by the Election Commission of India. As per this programme, the draft electoral rolls had been published on 24.01.2012. The process upto the stage of presentation of claims and objections to the Revising Authority concerned has already been completed and the same shall be disposed of by them upto 08.02.2012.

2. Deputy Commissioner, Jind vide memo No. 330 / LFA, dated 06.02.2012 has informed that the Revising Authority of Municipal Committee, Julana has reported that during the process of preparation of electoral rolls of this Committee 1236 application forms of claims and objections have been received, which require a lot of time to settle these applications and has requested to extend two days more.

3. In exercise of the powers conferred under Clause(1) of Article 243ZA of the Constitution of India read with Section 3A of the Haryana Municipal Act, 1973 and the rules made thereunder, the State Election Commission, Haryana, hereby revise the programme for the preparation of electoral rolls of all wards of Municipal Committee, Julana District Jind as under :-
