Sir/Madam,

This is with the reference of minutes of video conferences held on 14.1.2010 and 29.1.2010, circulated by the Commission under No. SEC/4E-III/2010/I04-152, dated 29.1.2010 and No. SEC/2ME/2010/223-245-dated 03-02-2010 respectively.

2. I am directed to refer on the subject noted above and to say that as per decision taken in the video conference stated above that master copy of voters list/electoral rolls of Panchayati Raj Institutions and Municipalities shall be prepared at district level as directed vide notification No. SEC/4E-III/2010/I04-152, dated 29.1.2010 and No. SEC/2ME/2010/223-245-dated 03-02-2010 . The data of these rolls shall be entered in database in such a manner that 40 names on the title page in the case of Panchayati Raj Institutions and 50 names in the case of municipalities of the voters/electors with heading extra in double columns and 100 names on the subsequent pages on white paper of A4 size get adjusted.

3. It is further informed that the following firms have been taken on panel by the State Election Commission, Haryana, for printing of 30 copies of voters list/ electoral rolls in respect of PRIs/Municipalities, for conduct of

Panchayats and Municipal General Elections, 2010, @ 0.66 (Sixty six paises) on the terms and conditions prescribed by the Commission(copy enclosed).
