**NOTICIATON**

Dated the 7<sup>th</sup> July, 2010.

No.SEC/3E-II/2010/5630:- Whereas reports have been received from the Deputy Commissioners-cum-District Election Officers (Panchayat), Hisar, Panipat, Karnal, Rohtak, Gurgaon and Sirsa that due to errors in printing of ballot papers, eruption of violence, snatching and destruction of ballot papers, Electronic Voting Machines, Ballot Boxes and other election material error in allotment of symbols etc. at some polling booths of the aforementioned districts, the poll process at these booths has been vitiated and the poll has not been conducted as per the provisions of the Haryana Panchayati Raj Act, 1994 and Rules framed thereunder and as per directions issued by the State Election Commission from time to time.

2. Whereas the State Election Commission, after having examined the recommendations received from the Deputy Commissioners-cum-District Election Officers (Panchayat), concerned Returning Officer (Panchayat) and taking all material circumstances into account, is satisfied that the poll process has been vitiated at the polling booths/stations of aforesaid districts.

3. Now, the State Election Commission in exercise of powers vested in under Rule 61 of the Haryana Panchayati Raj Election Rules, 1994, hereby declare the poll at these polling stations/polling booths to be void and orders for holding of fresh poll on 10.07.2010 from 07.00 A.M to 4.30 P.M for the offices of Panches, Sarpanches, Members Panchayat Samitis and Zila Parishads at the polling stations/polling booths already notified as per details given below :-

It may also be ensured that the contesting candidates have been informed about the above scheduled well in time.
