Subject : Panchayat Elections June, 2012 --- Model Code of Conduct.

Sir,

I am directed to refer to the subject cited above and to say that the State Election Commission, Haryana has issued notification No.SEC/3E-II/2012/1113, dated 30.05.2012 (copy enclosed) for the conduct of Bye Elections of the vacant seats of Panches, Sarpanches and Members of Panchayat Samitis in the State of Haryana and third General Election of Gram Panchayat, Hassanpur in district Palwal on 17.06.2012. The nominations for these Elections, as prescribed in the notification would start from 06.06.2012 to 08.06.2012. The date of scrutiny of nomination papers has been prescribed as 09.06.2012. The last date of withdrawal of nomination papers is 11.06.2012. The counting of votes in respect of Panches and Sarpanches shall be held immediately after the close of poll at the polling stations and in respect of Member Panchayat Samitis, it shall be held on 18.06.2012 at Block/District Headquarter.

2. As the election programme has been declared by this Commission on 30.05.2012, the Model Code of Conduct prescribed by the State Election Commission has come into operation with w.e.f. 30.05.2012 in the area where the poll is to be conducted.

3. Therefore, I am directed to request you that this may be brought to the notice of Hon'ble Chief Minister / Ministers / Chief Parliamentary Secretaries / Parliamentary Secretaries and other authorities and they may be requested to strictly follow the same. I am further directed to request you to invite attention of Hon'ble Chief Minister / Ministers / Chief Parliamentary Secretaries / Parliamentary Secretaries towards Para No.7 of the Model Code of Conduct (Part-II-for Government Department and Government servants), that no grant be sanctioned by them from the discretionary fund or from the Govt. fund nor will they sanction any scheme till elections are completed in all respect. During this period neither any foundation stone shall be laid nor will any scheme / plan be inaugurated. Any violation of the Model Code of Conduct will be viewed seriously by the State Election Commission.

4. I am further directed to say that State Election Commission will not hesitate to cancel the election in respect of above Panchayati Raj Institutions in case of any violation of the Model Code of conduct.
