Subject:- Ban on posting/transfer of officers/officials who are engaged in Panchayat General Elections, 2015.


Sir,

I am directed to refer to the subject cited above and to say that the State Election Commission, Haryana has issued notification No.SEC/3E-II/2015/10233, dated 15.12.2015 (copy enclosed) for the conduct of the Panchayat General Elections of the Panches, Sarpanches of Gram Panchayat and Members Panchayat Samitis and Zila Parishads in the State of Haryana for which poll shall be held on 10.01.2016, 17.01.2016 and 24.01.2016. The counting of votes in respect of Panches and Sarpanches shall be held immediately after the close of poll at the polling stations of the Gram Panchayat concerned. For the election of Members of Panchayat Samitis and Zila Parishads, the counting shall be held on 28.01.2016 at 8.00 A.M. at places specified by the District Election Officer (Panchayat).

2. In view of above, I am directed to request you that the officers/officials connected with the work of Panchayat General Election should not be transferred till the declaration of election results. However, in case, where it is considered necessary to transfer an officer/official connected with the above said Panchayat General Elections, prior approval of this Commission be obtained.

3. Necessary instructions in this regard may kindly be issued to all the Departments, Boards, Corporations etc. of the State Government under intimation to the State Election Commission, Haryana.


