The Commission vide Notification No. SEC/4E-II/2015/5534 dated 18th May, 2015 has issued the notification for the preparation of voter lists of Panchayati Raj Institution in 17 districts Sonapat, Yamuna Nagar, Sirsa, Panchkula, Faridabad, Palwal, Kaithal, Rohtak, Fatehabad, Hissar, Panipat, Narnaul, Rewari, Mewat, Kurukshetra, Jind and Jhajjar, where the work of wardbandi had been completed. As per programme, the draft publication of voters list was to be made on 13.06.2015 and claims and objections were to be submitted upto 22.06.2015 and decided upto 25.06.2015 by the District Electoral Officers.

Now, this Commission has received requests from various districts i.e. Sirsa, Mewat, Panchkula, Panipat, Fatehabad, Faridabad, Sonapat and Yamuna Nagar whereby Deputy Commissioners-cum-District Elections Officers (P) of these districts has intimated that so many claims and objections have been received in their districts and it is not possible to dispose of all these within the stipulated period. They have thus made the request to extend the date of the disposal of claims and objections in public interest.

In view of the request of Deputy Commissioners-cum-District Election Officers referred to above, the State Election Commission, Haryana in accordance with the provisions contained in Section 163, 164, 165 and 166 of the Haryana Panchayati Raj Act, 1994 read with Rules 8, 9, 9A, 10, 10A, 11 and 12 of the Haryana Panchayati Raj Election Rules, 1994 and powers conferred under Sub-Section (1) of Section 212 of the Haryana Panchayati Raj Act, 1994, hereby extends the voters list time schedule in respect of district Sirsa, Mewat, Panchkula, Panipat, Fatehabad, Faridabad, Sonapat and Yamuna Nagar from the stage of disposal of claims and objections and amend the relevant part of Notification(referred to above), as under: -

i.	Last date for disposal of claims and objections by the District Electoral Officers (Panchayat). {Rule 10 (1)}.	02.07.2015
ii.	Last date for filing an appeal before District Election Officer (P) against the decision of District Electoral Officer. {Rule 10 (2) }	07.07.2015
iii.	Last date by which the appeal shall be disposed off by the Appellate Authority { Rule 10 (2) and (3) }	14.07.2015
iv.	Final publication of voters list (Rule 10-A).	22.07.2015


