Whereas, State Election Commission vide its notification No.SEC/E-II/2016/2171, dated 10.02.2016 had notified the name of Sh.Surender Singh s/o Sh.Jagbir as Sarpanch, Gram Panchayat Gailpur, Block Palwal, District Palwal under section 161 (4) of the Haryana Panchayati Raj Act, 1994.

2. Whereas, election of Sh.Surender Singh s/o Sh.Jagbir as Sarpanch, Gram Panchayat-Gailpur, Block-Palwal, District-Palwal held on 10.01.2016 has been set aside as order dated 14.05.2018 passed by the Civil Judge (Sr. Div.), Palwal in CIS No. Election Petition No.10-2016 titled as Radha Vs. Surender and further ordered to conduct fresh election for the post of Sarpanch of village Gailpur as per the rules and procedure.

3. Whereas, Sh.Surender Singh has challenged the above said order in the Hon'ble Punjab and Haryana High Court, Chandigarh, through the CWP No.14629 of 2018. Hon'ble High Court vide order dated 11.12.2018 has dismissed the said petition.

4. And, whereas, the Deputy Commissioner, Palwal under dated 01.01.2019 has removed Sh.Surender as Sarpanch, Gram Panchayat Gailpur, in exercise of powers conferred under Section 51(3) of the Haryana Panchayati Raj Act, 1994 and declared the vacancy under Section 177 of the Act *ibid*.

5. In view of above, the State Election Commission, Haryana hereby de-notifies the name of Sh. Surender Singh s/o Sh.Jagbir as Sarpanch, Gram Panchayat Gailpur, Block Palwal, District Palwal with immediate effect.
