NOTIFICATION

Dated, the 18th March, 2019

No. SEC/4E-II/2019/314:- Whereas the Commission had notified the name of Sh. Shakil as elected Panch ward No. 6 Gram Panchayat, Ali Meo vide its notification No. SEC/E II/2016/2167 dated 10.02.2016.

2. Whereas, Hon'ble Election Tribunal Hathin in an Election petition titled Mehboob Khan @Jakir Vs. Shakeel vide order dated 28.09.2016 has quashed the election of Sh. Shakeel, Panch ward no. 6 of Gram Panchayat, Ali Meo held on 17.01.2016 and declared Sh. Mehboob Khan @ Jakir as elected Panch ward No. 6, Gram Panchayat Ali Meo. The appeal against this order filed by the aggrieved party had been withdrawn.

3. Deputy Commissioner-cum-District Election Officer (P) Palwal vide letter No. 10687/Panchayat, dated 15.03.2019 has reported that Hon'ble Punjab and Haryana High Court vide its order dated 06.02.2019 passed in CWP No. 21046 of 2018 – Shakeel Vs. Mehboob Khan @ Jakir & others partly allowed the appeal and directed the respondents no. 2 and 3 to hold the fresh election for the post of Panch of ward no. 6, Gram Panchayat Village Ali Meo within a period of two months from today.

4. In compliance of above orders of Hon'ble High Court, the State Election Commission, Haryana denotes the name of Sh. Shakil as elected Panch of ward no. 6, Gram Panchayat, Ali Meo with immediate effect and further in exercise of powers vested under clause (1) of Article 243K of the Constitution of India and under Rule 24 of the Haryana Panchayati Raj (Election) Rules, 1994 and all other powers enabling me in this behalf and in pursuance of the provisions contained in Sub-Section (1) of Section 161 and Sub-Section (2) of Section 211 of the Haryana

Panchayati Raj Act, 1994, hereby prescribe time schedule for the conduct of election of Panch ward No. 6 of Gram Panchayat- Ali Meo as per programme stated below:-

2.	Dates on which Nomination papers shall be presented under Rule 24(2) (i).	28.03.2019 to 02.04.2019 (10.00 A.M to 3.00 P.M.) (except 31.03.2019 being gazetted holiday)
3.	Dates on which the list of Nomination papers received shall be pasted under Rule 24(2) (ii).	28.03.2019 to 02.04.2019
4.	Date by which Affidavit/declaration shall be furnished by the candidate in Form 4-A & 4-B, to the concerned Returning Officer. (Rule 27).	28.03.2019 to 02.04.2019
5.	Date on which the nomination papers shall be scrutinized under Rule 24(2)(iii).	03.04.2019 (10.00 A.M. onwards)
6.	Last date for withdrawal of candidature by a candidate under Rule 24(2)(iv).	04.04.2019 (upto 3.00 P.M.)
7.	Date on which symbols shall be allotted to the contesting candidates.	04.04.2019 (After 3.00 PM)
8.	Date on which the list of contesting candidates shall be pasted under Rule 24(2)(v).	04.04.2019 (immediately after the allotment of symbols)
9.	Date on which the poll, if any, shall be held under Rule 24(2) (vi).	12.04.2019 (Friday)
10.	Timing of the poll	Between 8.00 A.M. to 4.00 P.M.
11.	Counting of votes	i) Immediately after the close of poll. ii) In case of re-poll, the Commission may change the date and time of counting of votes.

It is further directed as under:-

- a) If there is any stay order passed by any competent authority or Court against this vacancy, the election to this seat shall not be held and a report to that effect be sent to the Commission, immediately.
- b) **The programme for updation of voter list issued under notification No. SEC/3E-II/2019/262-70, dated 01.03.2019 in respect of Panch ward No. 6, Gram Panchayat Ali Meo only stands withdrawn with immediate effect. The existing voter list shall be used for holding the election of Panch ward no. 6, Gram Panchayat, Ali Meo.**
- c) During the period of election, no new development work in the area concerned is started.
- d) The District Election Officer (Panchayat) Palwal shall by notice in Form 2 or 3, as the case may be, specify the above programme i.e. (i) last date, time and place of making nominations; (ii) the date, time and place for scrutiny of the nomination papers (iii) date and time for withdrawal of candidature (iv) preparation of list of contesting candidates and allotment of symbols (v) date and time during which the poll will be held and (vi) date, time and place of counting of votes in accordance with the provisions contained in Rule 24 of the Haryana Panchayati Raj (Election) Rules, 1994 and will send a copy of the notice to the Commission by fax or email.
- e) Nomination papers for this seat shall be filed and received at Headquarter of the Gram Panchayat concerned by the Returning Officer/Assistant Returning Officer.
- f) The work of scrutiny of nomination papers should not be delegated to the Assistant Returning Officer.
- g) The Returning Officer shall supply nomination paper (Form-4) and affidavit/declaration forms i.e. Form 4-A & 4-B on demand to the contesting candidates.
- h) The Returning Officer shall also obtain an affidavit/declaration in Form 4-A and 4-B (reflecting the latest position of dues etc.) alongwith required documents during the prescribed period mentioned at Sr. No. 4 of the time schedule, from those candidates who have filed the nomination.
- i) The Returning Officer shall make the scrutiny of all the nomination papers on the day fixed for scrutiny.
- j) Immediately after the withdrawal of candidature, the Returning Officer shall prepare a list of contesting candidates in the prescribed forms i.e. in Forms 6, 7 and 8 (as the case may be) and shall mention the symbol allotted to the contesting candidates against his/her name at column No. 4. After the allotment of symbol, the signature of the contesting candidates or his election agent should be obtained in the relevant form as token to

the fact that the candidates have been informed about the symbol allotted to him/her.

2. It is further directed that the counting of votes shall be done immediately after the close of poll at the polling stations, but before starting counting, the Returning Officer concerned shall ensure that the voting at the polling booths under his control has been completed. If re-poll is recommended, the Commission may change the date and time of counting.

3. It is further directed that all voters of the respective area who have been issued the Electoral Photo Identity Cards for Assembly and Lok Sabha Elections and the Electoral Photo Identity Card numbers mentioned in case of the Panchayat Voters list also, shall have to produce these cards to exercise their franchise when they come to the polling stations for voting. If any elector has not been issued Electoral Photo Identity Cards by the Election Commission of India, he/she will have to produce any one out of the following documentary evidence to establish his/her identity:--

i)	Driving License,
ii)	Income Tax Identity (PAN) Card,
iii)	Service Identity Card issued to employees by Central/State Government Offices, Public Sector Undertakings, Local Bodies or other public Limited Company,
iv)	Pass Book of accounts, having photograph, opened in a scheduled bank or post office,
v)	Freedom Fighter Identity Card having photograph,
vi)	SC/ST/OBC certificate having photograph, issued by competent authority
vii)	Certificate of Physical Handicap having photograph issued by the Competent Authority,
viii)	Arms License having photograph,
ix)	Job Cards with photograph issued under the National Rural Employment Guarantee Scheme,
x)	Property documents with photographs such as Pattas, Registered Deeds etc,
xi)	Pension Documents such as Ex-Servicemen Pension Book/Pension Payment Order, Ex-Servicemen's Widow/Dependent Certificate, Old Age Pension Order, Widow Pension Order, with photograph,
xii)	Health Insurance Scheme Smart Cards with Photograph,
xiii)	Ration Cards or any other similar documents establishing identity of the electors to the satisfaction of the Presiding Officer, having photograph.

xiv)	Aadhar Card issued by UIDAI
xv)	Passport

4. It is further directed to make the following security arrangements for the conduct of free, fair and peaceful elections.

- i. Adequate police personnel shall be deployed at the polling stations, counting centers for security and maintenance of law and order to ensure peaceful, smooth and fair election.
- ii. Provide security to the contesting candidates, if they desire so.
- iii. It shall be ensured that no untoward incident takes places during elections.

5. In order to curb undesirable and illegal activities, the Commission hereby imposes restriction to hire or procure not more than 2 vehicles or vessels whether on payment or otherwise for use by a contesting candidate himself or his agents or his supporters on the day of poll during the Panchayat Election. Permit in this respect shall be issued in the performa given here as under:-

6. It is further directed that the votes for this election shall be given by recording of votes by voting machines [Electronic Voting Machines (EVMs)].


