### NOTIFICATION

No. SEC/3E-II/2018/1450

Dated: 29<sup>th</sup> August, 2018

Whereas, on the recommendation of Deputy Commissioner, Jhajjar, name of Sh. Charan Singh son of Sh. Jagdish was notified by the Commission vide notification No. SEC/E-II/2016/2080, dated 10.02.2016, as elected Panch from Ward No.3 of Gram Panchayat, Salhawas, during the general election held in January, 2016.

2. Whereas, the Deputy Commissioner, Jhajjar vide its memo No. 3547/Panchayat, dated 05.07.2016 had informed that the Presiding Officer had erroneously mentioned the votes obtained by the contesting candidates upside down against each other. But in the form 14 and 18 Sh. Jai Parkash was declared as elected candidate. Due to confusion and erroneously mentioning the votes obtained by the contesting candidates upside down against each other, the name of Sh. Charan was mentioned as elected Panch from ward No.3 of Gram Panchayat, Salhawas which was incorrect and requested to correct the name of Sh. Jai Parkash in place of Sh. Charan Singh, in the notification.

3. Whereas, the Commission, vide its memo No. SEC/3E-II/2016/5200, dated 20.07.2018 had asked the Deputy Commissioner, Jhajjar to clarify in whose favour the election certificate was issued, who has taken oath of the seat of Panch of Ward No.3, Gram Panchayat, Salhawas, and whether the written statement of both the candidates had been obtained or not ? If yes, supply a copy of the same and if no, obtain the same immediately and send to the Commission.

4. Whereas, the Block Development and Panchayat Officer, Jhajjar vide its endst. No.1059, dated 20.07.2018 has clarified that Sh. Jai Parkash was duly elected from ward No. 3 of Gram Panchayat, Salhawas by the concerned Returning Officer, Sh.

Jai Parkash had taken oath from ward No.3 of the said Gram Panchayat and as per written statement of the Block Development and Panchayat Officer 10.07.2018 election certificate has been issued by the Presiding in favour of Sh. Jai Parkash. As per statement of both Sh. Charan Singh and Jai Parkash each have claimed obtaining of 109 votes; but the election certificate has been issued in favour of Sh. Jai Parkash and oath has also been administered to Sh. Jai Parkash.

5. In view of the recommendation of the Deputy Commissioner, Jhajjar and legal advice obtained in the matter, the Commission has decided to de-notify the name Sh. Charan Singh son of Sh. Jagdish, Panch from Ward No.3, Gram Panchayat, Salhawas from the notification issued vide No. SEC/E-II/2016/2080, dated 10.02.2016 and further notifies the name of Sh. Jai Parkash son of Sh. Balbir Singh, in his place.
