### NOTIFICATION

Dated, the 30<sup>th</sup> March, 2018

No. SEC/4E-II/2018/510 : Whereas, the Commission, issued programme for the conduct of bye election to ward No. 1 of Zila Parishad, Gurugram vide notification No. SEC/4E-II/2018/358, dated 09.03.2018. The nomination papers were to be presented between 17.03.2018 to 22.03.2018 and the polling was scheduled to be held on 08.04.2018.

2. Whereas, the Commission in compliance with order dated 20.03.2018, passed by the Hon'ble Punjab & Haryana High Court in CM No. 1038 of 2018, stayed the election programme vide its notification dated 22.03.2018.

3. Whereas, Hon'ble Supreme Court of India vide its order dated 28.03.2018 passed in SLP No. 11273 of 2018- State Election Commission, Haryana Vs Poonam & others, has stayed the operation of above said order of the Hon'ble Punjab and Haryana High Court, till the next date of hearing and the case has been listed for 16<sup>th</sup> April, 2018.

4. Whereas, State Election Commission, Haryana in exercise of powers vested under clause (1) of Article 243K of the Constitution of India and under Rule 24 of the Haryana Panchayati Raj (Election) Rules, 1994, and all other powers enabling in this behalf and in pursuance of the provisions contained in Sub-Section (1) of Section 161 and Sub-Section (2) of Section 211 of the Haryana Panchayati Raj Act, 1994, hereby prescribe time schedule for the conduct of elections to the seat of Member Ward No. 1, Zila Parishad, Gurugram as under:-

2.	Dates on which the list of Nomination papers received shall be pasted under Rule 24(2) (ii).	31.03.2018 to 03.04.2018
3.	Date by which Affidavit/declaration shall be furnished by the candidate in Form 4-A & 4-B, to the concerned Returning Officer. (Rule 27).	31.03.2018 to 03.04.2018
4.	Date on which the nomination papers shall be scrutinized under Rule 24(2)(iii).	04.04.2018 (10.00 A.M. onwards)

5.	Last date for withdrawal of candidature by a candidate under Rule 24(2)(iv).	05.04.2018 (up to 3.00 P.M.)
6.	Date on which symbols shall be allotted to the contesting candidates.	05.04.2018 (After 3.00 PM)
7.	Date on which the list of contesting candidates shall be pasted under Rule 24(2)(v).	05.04.2018 (immediately after the allotment of symbols)
8.	Date on which the poll, if any, shall be held under Rule 24(2) (vi).	15.04.2018 (Sunday)
9.	Timing of the poll	Between 8.00 A.M. to 4.00 P.M.
10.	Counting of votes	i) Immediately after the close of poll. ii) In case of re-poll, the Commission may change the date and time of counting of votes.

It is further directed that:

- i. Deputy Commissioner–cum-District Election Officer, Gurugam shall give wide publicity to the above programme by munadi in area concerned, Paid advertisements in two local news papers and through electronic media shall be inserted .
- ii. The nomination papers received if any in pursuance of earlier notification dated 09.03.2018 shall also be considered and such candidates need not apply again.
- iii. The remaining instructions contained in the notification No.SEC/4E-II/2018/358, dated 09.03.2018 shall remain unchanged.
