Subject: Supply of information with regard to the availability of Ballot Boxes.

Sir/Madam,

I am directed to refer to the subject cited above and to say that the Election Commission of India (ECI) has conditionally transferred total 40,034 ballot boxes to the Commission in the year, 2007. A copy of the detail provided by the CEO, Haryana in this respect (Memo No. Election-2008/3AE/5814 dated 4th November, 2008) is attached herewith. The Deputy Commissioners-cum-District Election Officers (P) were consequently directed to take the physical possession of the transferred ballot boxes immediately. It was also made clear vide Commission's letter No. SEC/4E-III/2008/662-81 dated 18.01.2008 (copy enclosed) that if sufficient space for the placement of transferred/transferring ballot boxes is not available in any of the Govt. building in the district headquarter, then these may further be allocated to the BDPOs concerned after making necessary entries in the stock register. Despite this, the Commission vide its letter No. SEC/4E-III/2007/2078-80 dated 28.02.2007 also distributed its own 1500 ballot boxes (lying at district Ambala, Hisar and Gurgaon) to all the districts at the ratio of 100 and 50 ballot boxes.

2. In view of above, there are total 41,534 ballot boxes at district level (chart enclosed), but at the time of general election some of the districts refused to have the number of ballot boxes (shown against their name) available in their possession, resultantly the Commission has to face lots of difficulties for the distribution.

3. I am, therefore, directed to request you to take following steps in the matter and furnish the required information to this Commission immediately:-

- i) Go through the handing/taking over charge report and stock register of ballot boxes and prepare the detail accordingly.

ii). Compare the detail with the detail attached with CEO, Haryana's letter dated 04.11.2008 and chart of this Commission.

iii) Fill up proforma given here as under in view of the data derived from the record available and send the same alongwith supporting documents like handing/taking over charge report, copy of stock register etc. to this Commission, so that record be rectified accordingly and future inconvenience could be avoided:-

Subject: Panchayat General Election 2015-Distribution of Ballot Boxes.

Sir/Madam,

I am directed to refer to the subject cited above and to inform you that the General Election of Panchayati Raj Institutions in the State may most probably be conducted in two phases. In view of this, the Commission has decided that at least 80% of the total requirement of the ballot boxes must be available at each district, so that no difficulty may arise at the time of election. The Commission has accordingly prepared a chart (enclosed) as per requirement of various districts. You are, therefore, requested to collect or hand over the ballot boxes to the districts mentioned at column No. 11 (Remarks Column) of the chart. It is also made clear that the distribution of ballot boxes is only till the completion of General Elections and thereafter, same be returned immediately to the districts from where they have been lifted/collected.
