**NOTIFICATION**  
**The 14<sup>th</sup> July , 2022**

**No.SEC/3E-II/2022/761** The State Election Commission vide Notification No. SEC/3E-II/2022/269 dated 13<sup>th</sup> May, 2022 had issued schedule for preparation of the voters list of all Panchayati Raj Institutions, in the State of Haryana for the coming general elections which are due since 23.02.2021. As per the schedule, the voters list are finally required to be published on 22.07.2022.

2. The Deputy Commissioner-cum-District Election Officer (P), Sirsa vide letter No.1860/Election/Panchayat, dated 17.06.2022 had informed that the State Govt. has included wards No. 1, 2, and 3 of Gram Panchayat, Gobindpura in Municipal Council, Rania as a result of which wardbandi of Gram Panchayat, Gobindpura has been affected. Now the Deputy Commissioner-cum-District Election Officer (P), Sirsa vide letter No. 2279/PA/Panchayat-2022, dated 12.07.2022 has informed that wardbandi of Gram Panchayat Gobindpura, Block Rania has been finally published on 11.07.2022. He has requested to issue the schedule for preparation of voter list of Gram Panchayat Gobindpura, Block Rania, District Sirsa.

3. The Deputy Commissioner-cum-District Election Officer (P), Hisar vide letter No.Panchayat/election/2022/2612, dated 06.07.2022 has informed that after dissolution of the Municipal Committee Baas from Gram Panchayats namely Baas Khurd Bijan, Baas Akbarpur, Baas Aazamshahpur and Baas Badshahpur have been constituted and final publication of wardbandi of these newly constituted Panchayats has been made on 29.06.2022.

4. In view of the above, the State Election Commission, Haryana hereby directs to revise the schedule of preparation of voters list of Gram Panchayat Gobindpura in Block Rania, District Sirsa and Gram Panchayats Baas Khurd Bijan, Baas Akbarpur, Baas Aazamshahpur and Baas Badshahpur, Block Hansi II, District Hisar as per the following schedule :-

1.	Publication of ward wise and booth wise draft voters list of all wards of the Gram Panchayat, Gobindpura in Block Rania, District Sirsa and Gram Panchayats Baas Khurd Bijan, Baas Akbarpur, Baas Aazamshahpur, Baas Badshahpur, Block Hansi II, District Hisar for inviting claims and objections.{rule 8(3)}.	18.07.2022
2.	Last date by which claims and objections shall be presented to the District Electoral Officer in the prescribed forms 1A & 1B {rule 8 (4) (i to vi)}.	23.07.2022 up to 4.00 pm

3.	Last date by which claims and objections shall be disposed of by the District Electoral Officer {rule 8(4) (vii)}.	27.07.2022
4.	Last date for filing an appeal before Deputy Commissioner-cum-District Election Officer (P) against the decision of the District Electoral Officer {rule 8 (viii)}.	30.07.2022
5.	Last date by which the appeals shall be disposed of by the Appellate Authority {rule 8(4) (ix)}.	03.08.2022
6.	Final publication of the voters list (rule 8 (4)(ix)).	08.08.2022

3. The Deputy Commissioner-cum- District Election Officer (Panchayat) Sirsa and Hisar are directed to give wide publicity to the above revised schedule for preparation of Voters List

4. The remaining instructions issued earlier vide notification No.SEC/3E-II/2022/269, dated 13.05.2022 shall remain unchanged.

5. The Deputy Commissioner-cum-District Election Officer (P), Sirsa and Hisar shall ensure that voters list in respect of all wards of Gram Panchayat, Gobindpura in Block Rania, District Sirsa and Gram Panchayats Baas Khurd Bijan, Baas Akbarpur, Baas Aazamshahpur and Baas Badshahpur, Block Hansi II, District Hisar are prepared as per schedule given above.
