NOTIFICATION The 19th June, 2022

No.SEC/3E-II/2022/530 The State Election Commission vide Notification No. SEC/3E-II/2022/269 dated 13th May, 2022 had issued the schedule for the preparation of the voters list of all Panchayati Raj Institutions in the State of Haryana and as per the schedule the voters list required to be finally been published on 22.07.2022.

- 2. Now the Deputy Commissioner-cum-District Election Officer (P), Kurukshetra vide his letter No.237/Panchayat, dated 15.06.2022 has informed that the Govt. has included Gram Panchayat Pipli in Municipal Council, Thanesar resulting decrease of wards of Panchayt Samiti Pipli from 19 to 18 and ward No. 15, 16, 17 and 18 of Panchayat Samiti and ward No.8 & 9 of Zila Parishad have been affected. He has further informed that final wardbandi of the Panchayat Samiti, Pipli and ward No. 8 & 9 of Zila Parishad would be published on 20.06.2022.
- 3. In view of above, the State Election Commission, Haryana hereby directs to revise the schedule of preparation of voters list of all Gram Panchayats in Block Pipli, ward No. 15, 16, 17 and 18 of Panchayat Samiti, Pipli and ward No.8 & 9 of Zila Parishad Kurukshetra as per schedule given under:-

2.	Last date by which claims and objections shall be presented to the District Electoral Officer in the prescribed forms 1A & 1B {rule 8 (4) (i to vi)}.	29.06.2022 up to 4.00 pm
3.	Last date by which claims and objections shall be disposed of by the District Electoral Officer {rule 8(4) (vii)}.	06.07.2022
4.	Last date for filing an appeal before Deputy Commissioner-cum- District Election Officer (P) against the decision of the District Electoral Officer {rule 8 (viii)}.	12.07.2022
5.	Last date by which the appeals shall be disposed of by the Appellate Authority {rule 8(4) (ix)}.	15.07.2022
6.	Final publication of the voters list (rule 8 (4)(ix)).	22.07.2022

- 4. The remaining instructions issued earlier vide notification No.SEC/3E-II/2022/269, dated 13.05.2022 shall remain unchanged.

The Deputy Commissioner-cum-District Election Officer (P), Kurukshetra shall ensure that voters list in respect of all wards of Gram Panchayats in Block Pipli, ward No. 15, 16, 17 and 18 of Panchayat Samiti Pipli and ward No.8 & 9 of Zila Parishad Kurukshetra is prepared as per schedule given above.
