

**STATE ELECTION COMMISSION, HARYANA,

Dated:-11-11-2009.

As per provisions contained in Section 13 D and 13 E of Haryana Municipal Act, 1973, every contesting candidate of Municipal Committee has to maintain his election expenditure account from the date of his nomination till the declaration of result. As per orders dated 19.12.06, State Election Commission, Haryana has fixed the time limit i.e. 'within 30 days of declaration of result' to file the election expenditure with the Deputy Commissioner or any other officer prescribed by the State Election Commission, Haryana, and the candidates those who will not file his election expenditure account within time limit and make expenditure beyond expenditure limit fixed by the State Election Commission will be disqualified by the State Election Commission, Haryana for three years.

2. The General election to Municipal Committee, Pinjore, District Panchkula, was held on 30.12.2008. The following 18 candidates failed to lodge their election expenditure account within 30 days of declaration of the result:-

3. They were issued show cause notice as to why they should not be disqualified because they had not filed the election expenditure statement in time. They were personally heard by me on 5.11.2009 at 10.30 A.M. in the office of State Election Commission, Haryana . The following candidates came present for the hearing:-

4. Sh.Narayan Swaroop stated that he has deposited his expenditure accounts with the clerk of M.C.Office but he could not submit any proof for the same. Smt.Krishana Devi has stated that her grandson was not well so she could not submit her expenditure register. Smt.Rachna has stated that her father was ill so she could not submit her expenditure register and Smt.Kamini has stated that her son was out of station and she had no knowledge about the submission of expenditure register.

5. The explanation given by the four candidates mentioned at para No. 3 is not satisfactory as they could not show any good cause for their failure to file the election expenditure statement. All the other candidates neither came present before me nor they bothered to submit their election expenditure statement, Hence, as per provision provided in Section 13 D of the Haryana Municipal Act, 1973 all the 18 candidates mentioned at Para No. 2 are hereby disqualified for a period of 3 years from the date of this order.

As per provisions contained in Section 13 D and 13 E of Haryana Municipal Act, 1973, every contesting candidate of Municipal Committee has to maintain his election expenditure account from the date of his nomination till the declaration of result. As per orders dated 19.12.06, State Election Commission, Haryana has fixed the time limit i.e. 'within 30 days of declaration of result' to file the election expenditure with the Deputy Commissioner or any other officer prescribed by the State Election Commission, Haryana, and the candidates those who will not file his election expenditure account within time limit and make expenditure beyond expenditure limit fixed by the State Election Commission will be disqualified by the State Election Commission, Haryana for three years.

2. The General election to Municipal Committee, Pinjore, District Panchkula, was held on 30.12.2008. The three candidates Sh.Gurcharan Dhiman, ward No.2, Sh.Amar Chand Dhiman, ward No.4 and Sh.Sanjeev Kumar, ward No.11 failed to lodge their election expenditure account within 30 days of declaration of the result.

3. They were issued show cause notice as to why they should not be disqualified because they had not filed the election expenditure statement in time. They were personally heard by me on 5.11.2009 at 10.30 A.M. in the office of State Election Commission, Haryana . Sh.Gurcharan Dhiman, ward No.2. has stated that due to illness of his wife, he was not able to submit his expenditure register in time. Sh.Amar Chand dhiman, ward No.4 has stated that he was ill so he could not deposit his election expenditure register in time and Sh.Sanjeev Kumar, ward No.11 has stated that his mother was ill so he could not deposit his election expenditure register in time. All the three candidates have submitted medical certificate for late filing of their election expenditure register.

4. After taking into consideration the statement and medical certificate and after taking a lenient view Sh. Gurcharan Dhiman, Sh.Amar Chand Dhiman and Sh.Sanjeev Kumar are hereby exempted from filing their election expenditure statement beyond the prescribed time limit and the show cause notices issued to them are filed.
