NOTIFICATION

Whereas the State Election Commissioner, Haryana, in exercise of powers vested under clause (1) of Article 243ZA of the Constitution of India, Section 9(1) of the Haryana Municipal Corporation Act, 1994 and Rule 21(1) of the Haryana Municipal Corporation Election Rules, 1994 and all other powers enabling him in this behalf had issued the Election Programme for the conduct of election in all the Wards of Municipal Corporation, Faridabad vide Notification No.SEC/1ME/2005/20650, dated 29.3.2005, according to which the votes polled shall be counted immediately after the polling is closed, at the polling station itself on the same day i.e. 30.04.2005.

And whereas the Deputy Commissioner, Faridabad, vide his Memo No. M.C.E.-2005/726, dated 28/04/2005 has informed that there are 35 wards of Municipal Corporation, Faridabad having 729 polling stations. The counting of votes is to be done at the polling station itself. As there are large number of contesting candidates in some wards, so there is possibility of disturbance at the polling stations at the time of counting of votes. Thus, the Deputy Commissioner, Faridabad has requested that the counting of votes may be done at the following counting centers:-
