NOTIFICATION

No.SEC/1ME/2005/1871

Whereas the State Election Commissioner, Haryana, in exercise of powers vested under clause (1) of Article 243ZA of the Constitution of India, Section 3A of the Haryana Municipal Election Act, 1973 and Rule 19(1) of the Haryana Municipal Election Rules, 1978 and all other powers enabling him in this behalf had issued the Election Programme for the conduct of elections in all the Wards of 20 Municipal Councils and 27 Municipal Committees including Municipal Council, Karnal vide Notification No.SEC/1ME/2005/ 18000, dated 5.3.2005, according to which the poll shall be held on 16.4.2005.

And whereas the Financial Commissioner and Principal Secretary to Government Haryana, Urban Development Department, vide his Memo No.2AE/2005/16365, dated 15.4.2005 has informed the State Election Commission, Haryana that as per information received from the Deputy Commissioner, Karnal, ward bandi of Panchayat started on 30.8.2004 and was finally published on 21.9.2004. Similarly, final notification of ward bandi of Municipal Council, Karnal was published on 17.9.2004. 12 villages have been included in municipal limit of Municipal Council, Karnal after extension of limit and the details of these villages and number of voters is as under:-

And whereas the Financial Commissioner and Principal Secretary to Government, Haryana, Urban Development Department, has clarified that 7 Wards i.e. 1, 2, 3, 10, 11, 12 & 28 of Municipal Council, Karnal have been affected. In case election of these 7 Wards of Municipal Council, Karnal are cancelled, that there is no necessity of re-delimitation of these wards. As per the advice of L.R., it is the duty/ function of Panchayat Department to de-notify the 12 villages now included in the municipal limit. The Panchayat Department is being requested to take necessary action.

And whereas in view of the position explained above, he has requested to cancel the election process of these 7 wards to avoid further litigation and embarrassment to the State Government.

In view of the above position and after considering the request of the Financial Commissioner and Principal Secretary to Government, Haryana, Urban Development, in exercise of powers conferred under Section 3A of the Haryana Municipal Election Act, 1973 and Rule 19(7) of the Haryana Municipal Election Rules, 1978 and all other powers enabling me in this behalf, I, Chander Singh, State Election Commissioner, Haryana, hereby cancel the Election Programme to Ward Nos.1, 2, 3, 10, 11, 12 & 28 of Municipal Council, Karnal. The poll to these wards shall not be held on 16.04.2005. The election programme of these wards shall be issued separately. Those who have filed their nomination papers, those nomination papers should be kept intact and they will not be required to file fresh nomination papers, when the fresh Election Programme will be issued by the State Election Commission, Haryana. However, Deputy Commissioner, Karnal should also give a wide publicity in this regard and also inform the contesting candidate accordingly.
