## NOTIFICATION

In exercise of the powers vested under clause (1) of Article 243K of the Constitution of India and under Section 161 and Sub-section (2) of Section 211 and Section 212 of the Haryana Panchayati Raj Act, 1994 and under Rule 24 of the Haryana Panchayati Raj (Election) Rules, 1994 and all other powers enabling me in this behalf I, Chander Singh, State Election Commissioner, Haryana hereby prescribe the time schedule for conduct of **Panchayat Bye-elections to fill up seats of Panches, Sarpanches and Members Panchayat Samitis**, which have fallen vacant due to death, resignation, removal/disqualification or otherwise, the detail of which has been listed in Annexure "A" annexed herewith, for the remaining term. The Time Schedule as prescribed is given below:-

2. The District Election Officers (Panchayats), shall by notice in Form 2 or 3 as the case may be, specify the above programme i.e. (i) last date, time and place of making nominations; (ii) the date, time and place for the scrutiny of the nomination papers (iii) date and time for withdrawal of candidature and (iv) the date on which and the time during which the polling will be held (v) the date, time and place of counting of votes in accordance with the provisions contained in sub rule (a), (b) and (e) of Rule 24 of the Haryana Panchayati Raj (Election) Rules, 1994 and send a copy of the notice to the Commission by fax.

3. The State Election Commission further directs that the nomination papers for the election to members of Gram Panchayats and Sarpanches of Gram Panchayats shall be filed and received at Gram Panchayat Head Quarter, to the elections to Members of Panchayat Samitis shall be filed and received at Block Head Quarter by the Returning Officer (Panchayat)/Returning Officer (Panchayat Samiti)/Assistant Returning Officer (Panchayat)/Assistant Returning Officer (Panchayat Samiti). The State Election Commission further directs that the **work of scrutiny of the nomination papers shall not be delegated to the Assistant Returning Officer.**

4. The State Election Commission further directs that the signatures of the candidate or his election agent should be obtained on the nomination paper for allotment of symbol to the candidates in token of the fact that the candidates have been informed about the symbols allotted to him.

5. The State Election Commission also directs that the Returning Officer (Panchayat) shall supply copy of the prescribed form regarding criminalization of politics, declaration of assets and liabilities, educational qualification (annexure-III), to the contesting candidates with the nomination form. The Returning Officer (Panchayat) shall also obtain a dated receipt in the prescribed form of issuing the copies of the proformas and retain with the nomination papers.

6. The State Election Commission further directs that if there is any SLP/Writ Petition/Election Petition pending in any competent court against these vacancies, then the election to that seat will be subject to the condition of final outcome of the said petition and further if there is any stay granted by the competent court, in that case election shall not be held.
