No.SEC/2E-III/2005/938 :-Whereas reports have been received from the Deputy Commissioners-cum-District Election Officers (Panchayat), Jhajjar, Gurgaon, Hisar Faridabad and Panchkula that due to certain errors and irregularities in procedure, eruption of violence, snatching of ballot papers & ballot boxes and destruction of ballot papers and result sheets and other election material at the concerned polling stations/polling booths in the aforementioned districts the poll process in respect of certain polling stations in the districts have been vitiated and the polls have not been conducted as per the provisions of the Haryana Panchayati Raj Act, 1994 and Rules framed thereunder and as per directions issued by the State Election Commission from time to time.

Whereas the State Election Commission after having examined the recommendations received from the Deputy Commissioners-cum-District Election Officers (Panchayat), concerned Returning Officer (Panchayat) and taking all material circumstances into account is satisfied that in the polling stations/booths of aforesaid districts, the poll process has been vitiated at various polling stations in the districts.

No.SEC/2E-III/2005/969:-Whereas the Deputy Commissioners-cum-District Election Officers (Panchayat), Sirsa vide fax No.3679/Panchayat Elections, 2005, dated 10.04.2005 has reported that the Returning Officer (Panchayat) Village Gudiakhera, Block Nathusari Chopta vide his letter dated 10.04.2005 has informed that during the polling, law and order problem arose and the voters were not able to cast their votes. Ballot Papers at Polling Station No.150 were snatched by unknown persons and marked copies of electoral rolls were also snatched away. The whole village assembled and there being no electricity the records pertaining to all booths was tampered by unknown persons. All this vitiated the election process/polling of votes and also recommended repoll at all the polling stations in village Gudiakhera under rules. He has recommended to issue orders of re-poll under rule 61 of the Haryana Panchayati Raj Election Rules, 1994.
