NOTIFICATION

No.SEC/E-III/2005/ 397:- Whereas the reports have been received from the Deputy Commissioners-cum-District Election Officers(Panchayat), Jhajjar and Kaithal that the proceedings at the polling stations/polling booths for the polls were interrupted and obstructed by way of open violence. The Returning Officers(Panchayat)/Presiding Officers for such polling stations/polling booths had announced adjournment of poll to a next date to be fixed later.

Whereas the State Election Commission after having examined the recommendations received from the Deputy Commissioners-cum-District Election Officers (Panchayat), Jhajjar & Kaithal based on the reports of the Returning Officers(Panchayat) is satisfied that the polling on these polling stations/polling booths have not been completed.

Now, the State Election Commissioner in exercise of powers vested in him under Rule 59 of Haryana Panchayati Raj Election Rules, 1994 hereby fixes the polling dates on which the poll on these polling stations/polling booths shall recommence on dates shown against each district/case from 8.00 A.M. to 4.00 P.M.

The State Election Commissioner also directs that counting of votes for Panches and Sarpanches shall be taken up on the same day after the close of poll and counting for the concerned wards of Panchayat Samitis and Zila Parishads shall be taken up on 12.04.2005 at places to be notified by the respective District Election Officer(Panchayat).
