Whereas the programme for the preparation of list of voters in respect of all wards of Gram Panchayats, Panchayat Samitis and Zila Parishads in the State of Haryana for the conduct of Third Panchayat General Elections was issued by the State Election Commission vide its notification No.SEC/2E-III/2004/13021, dated 07.12.2004. According to this notification the list of voters of all wards of Gram Panchayats, Panchayat Samitis and Zila Parishads is to be prepared on the basis of Assembly electoral rolls published on 23.02.2004 with reference to 01.01.2004 as qualifying date and the draft publication of this list of voters is to be published for inviting claims and objections on 11.12.2004.

And whereas, on the recommendations of some Deputy Commissioners in the State of Haryana, the matter has been reconsidered by the Commission and it has been decided that the persons who will attain the age of 18 years on the date of receipt of claims and objections i.e. 15.12.2004 shall also be eligible to get themselves registered as voters in the list of voters.

And whereas, in accordance with the provisions contained in Section 163, 164, 165 and 166 of the Haryana Panchayati Raj Act, 1994 read with Rule 8, Rule 9, Rule 10, Rule 11 and Sub-Rule 2 of Rule 12 of the Haryana Panchayati Raj Election Rules, 1994, and in exercise of powers conferred under Sub-Section (1) of Section 212 of the Haryana Panchayati Raj Act, 1994, the State Election Commission,

Haryana hereby directs that after the last date of receipt of claims and objections i.e. 15.12.2004, no name will be entered in the Panchayat voters list till the completion of the Third Panchayat General Elections.
