NO.SEC/2ME/2016/239: Whereas, the State Election Commission, Haryana had prescribed a programme vide its notifications No.SEC/2ME/2016/54 dated 29.01.2016 for the preparation and the revision/updating of existing ward-wise and booth-wise photo based electoral rolls in respect of all wards of Municipal Council, Bahadurgarh with reference to 1st January, 2016 as the qualifying date. As per programme, the claims and objections were to be filed by 29.02.2016.

2. Whereas, the Deputy Commissioner, Jhajjar, vide letter no.424/LFA, dated 03.03.2016, has informed that many people could not file their claim and objection due to difficulties and requested to extend the time of one week for filing claims and objections.

3. In view of the recommendation of the Deputy Commissioner, Jhajjar, in order to ensure the preparation of fair and error free electoral rolls, the State Election Commission, Haryana in exercise of powers conferred under Section 3A of the Haryana Municipal Act, 1973 and the rules made there under hereby revise the programme for the preparation and revision/updating of existing electoral rolls of all wards of the Municipal Council, Bahadurgarh, with reference to 1st January, 2016 as the qualifying date, as under : -

i	Last date by which the claims and objections shall be presented to the Revising Authority (Rule 9)	08.03.2016
ii	Last date by which the claims and objections shall be disposed off by the Revising Authority. (Rule-10(1)(i) (ii))	14.03.2016
iii	Last date for filing appeals with the Deputy Commissioner against the orders of Revising Authority. (Rule-10(2))	18.03.2016
iv	Last date for disposal of appeals by the Deputy Commissioner.(Rule 10(3))	28.03.2016
v	Final publication of Electoral Rolls.(Rule-11)	08.04.2016

4. The Deputy Commissioner, Jhajjar, shall give wide publicity of the above programme.
5. The remaining instructions issued vide notifications no. SEC/2ME/2016/54, dated 29.01.2016 shall remain unchanged.
