**Subject : Municipal Election, 2017 --- Prohibition of sale of liquor—
regarding.**

Sir,

I am directed to refer to the subject cited above and to say that the State Election Commission, Haryana has issued the notifications for the conduct of the General Elections of Municipal Corporation, Gurugram, Municipal Committees Barara (Ambala) and Radaur (Yamuna Nagar) and Bye Elections of W. No. 9, Municipal Committee, Pehowa (Kurukshetra), W. No. 2 of Municipal Committee, Pataudi (Gurugram) and W. No. 10 of Municipal Committee, Dharuhera (Rewari) vide Notification No.SEC/1ME/2017/1508 and SEC/1ME/2017/1520 dated 30.08.2017 (copies enclosed), respectively. As per schedule, the nomination for these elections shall start from 08.09.2017 and the poll shall be held on 24.09.2017. The counting of votes shall be done immediately after the close of poll at the polling stations and results shall be declared immediately after the completion of counting in all the wards.

2. In the discharge of its sacred constitutional responsibility of conducting and ensuring free and fair elections of the abovesaid municipalities, the State Election Commission proposes to take strict measures to create and preserve the atmosphere conducive for holding free, fair and peaceful elections reflective of the true choice of the electorate.

3. For meeting this objective, the State Election Commissioner, Haryana in exercise of powers conferred on it under Section 9 of the Haryana

Municipal Corporation Act, 1994, Section 3 A of the Haryana Municipal Act, 1973 and all other powers enabling him in this behalf, hereby directs that the State Government shall declare and notify 'dry days' under relevant laws for such period during Municipal election as are appropriate at or around the areas where the Municipal elections are to be held. Such period of 'dry days' so declared and notified must include the period of 48 hours ending with hour fixed for conclusion of poll and the day on which counting of votes is to be taken up.

4. The State Election Commission further directs that:-
- (I) No liquor shops, hotels, restaurants, clubs and other establishments' selling/serving liquor shall be permitted to sell/serve liquor to any person who so ever may be on the aforesaid dates.
 - (II) No proprietary clubs, star hotels, restaurants etc. and hotels run by anyone even if they are issued different categories of licenses for possession and supply of liquor, should be permitted to serve liquors on these days.
 - (III) The storage of liquors by individuals shall be curtailed during the above period and the restrictions provided in the Excise laws on the storage in unlicensed premises shall be vigorously enforced.
 - (IV) Steps shall also be taken to prohibit the sale of liquor in adjoining areas of above mentioned municipalities or wards where the elections are to be conducted, so that there are no chances of clandestine movement of liquor from those areas, wherein the restriction has not been in operation.

5. In pursuance of the above directions the State Election Commission hereby directs that the above ban be imposed within the jurisdiction of the areas, where the municipal elections are to be held and the areas adjoining to the jurisdiction thereof during the period from 23.09.2017 to 24.09.2017.

6. It is requested that a copy of order issued in furtherance of the above mentioned directions should be sent to the Commission without delay.
