Whereas, the State Election Commission, vide its notification No. SEC/2ME/2017/1471, dated 21.08.2017 has prescribed a schedule for the distribution of electors of the Legislative Assembly Constituency published on 10.01.2017 with reference to 1st January, 2017 as qualifying date, into the wards and booths of the Municipal Committee, Loharu in Bhiwani District. As per schedule, draft electoral roll has been published on 06.09.2017; last date for filing claims and objections was fixed 12.09.2017 and Last date by which the claims and objections were disposed of by 22.09.2017.

- 2. Whereas, the Deputy Commissioner, Bhiwani vide letter No. 3286/LFA, dated 10.10.2017 informed the Commission that due to the transfer of Administrator-cum-SDM, Loharu, the claims and objections have not been disposed off and further made the request to give more time for the disposal of claims and objections. The Commission accordingly revised the programme from the stage of disposal of claims and objections vide Notification No. SEC/2ME/2017/1892 dated 13.10.2017.
- Now, the Deputy Commissioner vide Memo No. 3388/L.F.A. dated 14.10.2017 has informed that the draft publication of the electoral rolls of Municipal Committee, Loharu has not been made according to the rules and as such, the electors of the Committee are complaining on the issue. The request has therefore been made to reschedule the electoral roll programme from the stage of preparation of electoral rolls. In view of the request of Deputy Commissioner, Bhiwani, the State Election Commission, Haryana hereby amend para No. 3 of Commission's Notification Nos. SEC/2ME/2017/1471 dated 21.08.20117 and No. SEC/2ME/2017/1892 dated 13.10.2017 and revise the schedule w.r.t. the preparation of the electoral rolls of Municipal Committee, Loharu, as under:-
