shall be on deputation with the Commission during the
Municipal Bye-elections**

Sir,

I am directed to refer to the subject cited above and to say that the State Election Commission, Haryana has issued the notifications for the conduct of the Bye-elections of Ward No. 19 of Municipal Corporation, Hisar and W. No.03 of Municipal Committee, Samalkha (Panipat), W. No. 09 of Municipal Committee, Pundri & W. No. 12 of Municipal Committee, Rajound (Kaithal) and W. No. 04 of Municipal Committee, Bawani Khera (Bhiwani) vide Notification No. SEC/1ME/2020/161 and SEC/1ME/2020/172 dated 04.02.2020 (copies enclosed), respectively. As per schedule, the nomination papers shall be presented from 12.02.2020 to 17.02.2020 and poll shall be held on 01.03.2020. Counting of votes shall be taken up after the close of poll in all the polling stations and result shall be declared immediately after the completion of counting.

2. As per Section 8D of the Haryana Municipal Corporation Act, 1994, and Section 13D of the Haryana Municipal Act, 1973, the provisions given under Section 28A of the Representation of the People Act, 1951 are to be mutatis mutandis applied in municipal elections. The provisions given under Section 28A of the Representation of the People Act, 1951, are reproduced here as under:-

"28A. Returning officer, presiding officer, etc., deemed to be on deputation to Election Commission.- The Returning Officer, Assistant Returning Officer, Presiding Officer, Polling Officer and any other officer appointed under this part, and any Police Officer designated for the time being by the State Government, for the conduct of any

election shall be deemed to be on deputation to the Election Commission for the period commencing on and from the date of the notification calling for such election and ending with the date of declaration of the results of such election and accordingly, such officers shall, during that period, be subject to the control, superintendence and discipline of the Election Commission".

3. In view of the above, I am, therefore, directed to request you to bring these provisions into the notice of all concerned for information and compliance.
