Sir,

I have been directed to refer to the above subject and to say that the State Election Commission, Haryana has issued notification for conduct of bye-election for the seat of President, Municipal Committee, Dharuhera, district Rewari and of five wards, namely Ward Nos. 3,4,7,8 & 9 of Municipal Committee, Ateli Mandi, district Mahendergarh vide Notification No. SEC/1ME/2021/3098 dated 19.08.2021 (copy enclosed). As per schedule, the nomination papers shall be presented from **27.08.2021 to 02.09.2021** (except on 29.08.2021 & 30.08.2021 being gazetted holidays) and the poll shall be held on **12.09.2021**. Counting of votes shall be taken up after the close the poll on all the polling stations and result shall be declared immediately after the completion of counting.

**2.** I have, therefore, been directed to request you to declare **12.09.2021** a public holiday for all the factories, commercial establishments, industrial undertakings, trade, shops etc., falling within the jurisdiction of the

municipalities, where poll shall be held on **12.09.2021**, to enable workers of the factories, commercial establishments, shops etc. located in the areas to cast their votes.

3. I have also been directed to request you that a copy of the orders issued in this respect may kindly be sent to the State Election Commission.


