NOTIFICATION

NO. SEC/2ME/2022/390 .- Whereas the State Election Commission, Haryana has issued programme for updating the electoral rolls of 42 Municipal Councils/Municipal Committees including the Municipal Council, Nuh, vide notification No. SEC/2ME/2022/102, dated 03.02.2022, according to which draft publication of electoral roll was to be done on 18.02.2022. The last date for presenting claims and objections was prescribed as 24.02.2022 and the claims and objections were to be disposed off by the Revising Authority by 04.03.2022 and final publication was to be done on 16.03.2022.

2. However, the Deputy Commissioner, Nuh, vide his memo No. 1140, dated 03.03.2022, has sent a copy of memo No. 1751, dated 03.03.2022, of the Sub Divisional Officer (Civil), Nuh-cum-Revising Authority of Municipal Council, Nuh, in which she has informed that a large number of claims and objections have to be decided for which additional time of a week is required. The Deputy Commissioner, Nuh, agreeing with the request of the Revising Authority has recommended for extending the period of a week for disposing off the claims and objections.

3. In view of request of the Deputy Commissioner, Nuh, the State Election Commissioner, Haryana, in accordance with the provisions contained in section 3A of the Haryana Municipal Act, 1973, read with rule 4 of the rules made there under and the powers conferred under clause (1) of article 243ZA of the Constitution of India, hereby directs to revise the schedule for updating of electoral rolls of Municipal Council, Nuh, as given under:-

6. The Deputy Commissioner, Nuh shall ensure that the electoral roll of the Municipal Council, Nuh, is prepared as per the schedule given above.


